Sub: **Enhancement of the rates of various allowances on account of revision of rate of Dearness Allowance to 50% -regarding**

Ref: 67th Finance Committee Meeting held on 10.7.2024 (under Item No. 14) and 69th Executive Council Meeting held on 7.8.2024 [EC 69(5)]

Consequent upon the revision of the rates of Dearness Allowance to 50% with effect from 01.01.2024 vide Ministry of Finance, Department of Expenditure OM No. 1/1/2024-E.II (B) dated 12th March 2024 as adopted by the Jamia Hamdard, the rates of allowances (House Rent Allowance and Travelling Allowance) and with the approval of the FC and EC of Jamia Hamdard, **stand revised** with effect from 01.01.2024, in accordance with the Ministry of Finance, Department of Expenditure, Govt. of India Office Memorandum No.2/5/2017-E.II(B) dated 7 July 2017 regarding implementation of Recommendations of the 7th Central Pay Commission relating to grant of House Rent Allowance (HRA) to Central Government employees and (ii) No. 19030/1/2017-E IV dated 13 July 2017 as under:-


