

 Jamia Hamdard envisages following the relevant UN-Sustainable Development Goals (SDG). It was the pioneering university which implemented water harvesting system on the campus (<u>http://www.rainwaterharvesting.org/urban/jamia.htm</u>). It harvests over 60,000 cubic meters of water. University invested resources and earmarked funds for this project. For this initiative university won accolades and praise of local government.



- Jamia Hamdard has one of the most efficient water recycling and sewage treatment plants among Delhi universities.
- About 60% of area is covered by greenery.

- There is a Herbal Garden spreaded in 12000 sq. mt. of land with more than 150 varieties of herds/plants with potential medicinal value.
- All major buildings constructed in last 10 years have rooftop solar panels with substantial power generation.
- There has been an Environmental Quality Cell and an Students' Eco-Club to promote awareness about ecosystem and environmental consciousness.
- By a recent executive order the Environmental Quality Cell has been upgraded to 'Centre for Environmental and Sustainable Development'. The role of the Centre will be develop and implement sustainable development of campus and to prepare the university in sync with SDG.
- The above Centre has also been entrusted with task of proposing 'Climate Action Plan' keeping in view sustainable development and carbon action framework.

RESOLUTION NO. SC 158 (25) Dated: 12/10/2021

SC 158 (25): TO CONSIDER THE PROPOSAL OF PROF. M.Z. ABDIN REGARDING UPGRADATION OF EXISTING ENVIROMENTAL QUALITY CELL, JAMIA HAMDARD AS 'CENTRE FOR ENVIRONMENT AND SUSTAINABLE DEVELOPMENT (CEST).

In the meeting of 158 SC, Prof. M.Z. Adbin was requested to prepare a detailed 'DPR' to be submitted to the Haryana Wakf Board for acquiring land near Faridabad region that may be used, if provided, for skilled based agricultural training, introduction of courses and setting up an agriculture college / centre with the support of ICAR / Govt. agencies in future.
