Formatting Guidelines

Contributors must adhere the following formatting guidelines:

- Paper Title [Times New Roman, 16 Points, Bold, All Caps, Centre Align]
- Heading Level 1 [Times New Roman, 14 Points, Centre Align]
- Heading Level 2 [Times New Roman, 12 Points, Italics, Left Align]
- Heading Level 3 [Times New Roman, 12 Points, Left Align]
- Main Text [Times New Roman, 12 Points, Justify, 1.5" Spacing]
- Name of the case in the main text [Times New Roman, 12 Points, Single Line Spacing, Italics]
- Footnotes Text [Times New Roman, 10 Points, Single Line Spacing]
- Name of the Author(s) should not be written on the manuscript.

Cover Page:

All submissions should be sent with a covering letter indicating the Name of the Author, Institutional Affiliation, Contact Details and the Topic of the paper

Abstract:

All submissions must be accompanied by a 200 word abstract and a minimum of 3 Keywords.
