

All the students appearing for the 3<sup>rd</sup> Professional MBBS (Part 1<sup>st</sup>) Annual Examinations 2025 (Batch: 2021) are hereby directed that the Examinations will be held as per the schedule and VENUE (Smart Class Room Cluster, Central Library Building, Jamia Hamdard campus) for better monitoring as notified by the Office of the Controller of Examinations dated 16.01.2025.


