Through this Mediation Competition, the organizers seek to cultivate a vibrant platform for learning, networking, and innovation, inspiring participants to become leaders in the evolving landscape of dispute resolution.

# **RULE BOOK**

The ADRB hereby makes the following rules for the First Edition of HILSR National Mediation Competition, 2025 in Concordia 2.0.

## **1. GENERAL INFORMATION**

---

### **1.1 Language**

The Official Language of the competition, for all purposes, shall be English. All written and oral submissions shall be made in English.

### **1.2 Dress Code**

The Dress Code for the Competition shall be completely business formal. This mentioned dress code extends to the Inaugural and Valedictory Ceremony as well.

### **1.3 Platform**

The entire rounds of the competition shall take place in physical mode at the respective university premises.

### **1.4 Code of Conduct**

The Competition Administrator reserves the right to disqualify any team for any kind of misconduct on the part of any member of the team, during the Competition.



**1.5** In case of any doubt, the decision of the Competition Administrator shall be final and binding upon all the interested parties.

**1.6** In case of any changes in the Competition, the participants will receive email with such changes. However, participants are liable for not being aware of the changes being made to the competition, if any.

## **2. ELIGIBILITY CRITERIA**

---

**2.1** Subject to the criteria and conditions laid down by the respective colleges and Institutes, students pursuing their full time 3-year LLB or 5-year LLB program from a university or Institute recognized by the Bar Council of India, are eligible to apply.

**2.2** Students enrolled and pursuing post-graduate diploma or short-term certificate courses in law are not eligible to apply.

**2.3** Cross-Institute Teams shall not be eligible to participate in this Competition.

**2.4** Subject to the discretion of organizers, only 1 Team per Institute shall be allowed to register for this Competition.

**2.5** Subject to the provisions of this Chapter, the Organizing Committee shall accept the registration of a maximum of 12 Teams on first come first serve basis.

## **3. COMPOSITION OF TEAMS**

---

**3.1** Each team shall consist of three (03) participants, namely, one mediator and one client-counsel pair (Negotiating Team). However, the roles of the mediator and the client-counsel pair cannot be interchanged, in any rounds.

## **4. APPLICATION PROCEDURES**

---

**4.1** Each Team shall register themselves through the registration form which link is enclosed herewith. It can be accessed at: <https://forms.gle/vghUsx85CQNT3tmH8>

**4.2** Each Team shall mandatorily submit the complete registration form enclosed herewith. Teams must not forget to attach the proof of fee payment in the form.

**4.3** At the time of registration, teams must attach a NOC from the University Head/Dean/Director. The same must be attached with the form.

**4.4** The last date for registration shall be **February 03, 2025**.

## **5. REGISTRATION PROCEDURE**

---

**5.1** The Participating Team shall mandatorily fill their necessary details as contained in the enclosed link of the form.

**5.2** The registration fee shall be inclusive of kits, food, accommodation (From **February 21, 2025 | 7:00 AM** onwards to **February 22, 2025 | 08:00 AM** only. In **case of emergencies or urgency**, accommodation maybe granted from **February 20, 2025**, from **7:00 P.M.**, subject to additional charges).

**5.3** The Organizing Committee will send a confirmation of participation email after verifying the entire process as enlisted under the clauses.

**5.4** After filling the form, the registered teams shall receive a team code, which shall be used for any further communication.

## **6. PAYMENT PROCESS**

---

**6.1** The registrations charges are as follows:

## **7. STRUCTURE OF THE COMPETITION**

---

**7.1** The Competition shall comprise of Qualifying Rounds and Advanced Rounds.

**7.2** The Qualifying Rounds shall consist of a Preliminary Round and the Advanced Rounds shall consist of three knock-out rounds viz, Quarter-Final Round, Semi-Final Round, and the Final Round.

**7.3** The competition will be held from **February 21, 2025** to **February 21, 2025**. The Preliminary Round, Quarter-Final round and Semi-Final round shall be conducted on **February 21, 2025** followed by the Final Rounds on **February 21, 2025**.

## **8. COMPETITION PROCEDURE**

---

### **8.1 Preliminary Round**

**8.1.1** The preliminary round shall be conducted for 25 minutes followed by 5 minutes for Judges' feedback, which will be a knock out round.

**8.1.2** Each Team shall be once the Responding Party and once the Requesting Party in each session which will be determined by draw of lots.

**8.1.3** Subject to the organizers' discretion, the panel of judges will be changed based on the condition of maintaining the anonymity of the competition.

**8.1.4** Subject to the discretion of the judges, if a team exceeds the given time frame for the Mediation Session, there shall be a negative marking of 1 for every 2 minutes exceeded.



## **8.2 Quarter-Final Rounds**

**8.2.1** The top 6 Teams from the Preliminary knock-out Round will proceed to the Quarter-Final Round, which will also be a knock out round.

**8.2.2** The Quarter-Final will be of 35 minutes followed by 5 minutes for Judges' feedback.

**8.2.3** The Team will be required to only represent the Responding Party or the Requesting Party which will be determined by the Draw of Lots

## **8.3 Semi-Final Rounds**

**8.3.1** The top 4 Teams from the Quarter-Final Round will proceed to the Semi-Final Round, which will also be a knock out round.

**8.3.2** The Semi-Final Round will be of 35 minutes followed by 5 minutes for Judges' feedback.

**8.3.3** The Team will be required to only represent the Responding Party or the Requesting Party which will be determined by the Draw of Lots.

## **8.4 Final Round**

**8.4.1** The top 2 Teams from the Semi Final Round will proceed to the Final Round.

**8.4.2** The Final Rounds will be of 45 minutes followed by 10 minutes for Judges' feedback.

## **9. CONFIDENTIAL PROBLEM**

---

**9.1** Participants shall assemble at the given venue specified by the Organizing Committee for release of confidential information 30 minutes prior to the allotted time slot.

**9.2** Participants shall not disclose the confidential information to any other Participant throughout the Competition. Any such disclosure made to other Participants before or after their round shall lead to immediate disqualification from the Competition without scope of appeal.

## 10. SCOPE OF INTERPRETATION

---

10.1 Participants shall restrict the interpretation of the problem to reasonable conclusions and are not allowed to create additional facts.

## 11. CLARIFICATIONS

---

11.1 The Team (s) may submit queries regarding the mediation problem during the prescribed time frame. The response to the Clarifications is subject to the drafter's discretion. The Clarifications will not be accepted after the given time.

## 12. AWARDS & PRIZES

---

12.1 The Team that scores the highest in the Final Round shall be declared as the **Winners** and shall be awarded an amount of INR 20,000, a trophy, and a certificate of merit.

12.2 The team qualifying for the Final Round but not securing the top spot shall be declared as the **1st Runners-Up** and be awarded INR 15,000, a trophy, and a certificate of merit.

12.3 The team qualifying for the Semi-Final Round with the third-highest score, and based on 3rd highest score shall be declared as the **2nd Runners-Up** and be awarded INR 10,000, a trophy, and a certificate of merit.

12.4 The **Best Mediator** will be awarded a Trophy and a Certificate of Merit.

12.5 Every Participating Team shall receive a **Certificate of Participation**.

## 13. SCOUTING

---

13.1 No member of any Team will be permitted to witness the proceedings in any Conference Room in which that Team is not one of the participating Teams whilst that Team is a part of the Competition.

13.2 In case of any violation of the rule, the Organizing Committee shall take strict actions, which may include but not limited to, the expulsion of the said Team from the Competition.

## 14. ACCOMMODATION

---

**14.1** Accommodation shall be provided to the participants by organizers during the days of the competition.

**14.2** The accommodation will start from **February 21, 2025 | 07:00 AM** onwards to **February 22, 2025 | 08:00 AM** only.

**14.3** However, the organizing committee may make further modifications to accommodation plan, and the same shall be communicated to the participants in due course. In case of emergencies or urgency, accommodation maybe granted from **February 20, 2025** from **7:00 P.M.**, subject to additional charges.

- **Body of the Submission:** Times New Roman, Font Size 12, 1.5 Line Spacing, Justified Alignment and 1-inch margins on each side.
- **Footnotes:** Times New Roman, Font Size 10; Line - 1 and justified alignment

**4.6** The author(s) shall submit an unpublished and original work and shall refrain from submitting the manuscript elsewhere during the pendency of the review process.

**4.7** The last date for the submission of Research Paper is **February 05, 2025.**
