NOTIFICATION

Jamia Hamdard was formed as Society on 26th April, 1989 under the Societies Registration Act, 1860 after the receipt of the Letter of Intent (LoI) for declaring Jamia Hamdard as deemed to be University, issued by the Ministry of Education (Erstwhile Ministry of HRD), Department of Education vide F.No.9-18/85-U.3 dated 20th March 1989 on the recommendations of the UGC Inspection Committee.

2. The letter of intent issued by the Ministry of HRD was subject to the condition that the proposed Jamia Hamdard society will be an amalgamation of the following six institutions by merging with the proposed new society namely Jamia Hamdard after dissolution of their respective societies: -

- i. The Institute of History of Medicine and Medical Research;
- ii. Indian Institute of Islamic Studies;
- iii. Hamdard Tibbi College;
- iv. Hamdard College of Pharmacy;
- v. Majeedia Hospital and
- vi. The School of Nursing

3. Accordingly, the following four societies functioning in the existing Hamdard Nagar Campus, New Delhi-110062 were dissolved on 28.04.1989 and all the assets and liabilities were transferred to the Jamia Hamdard: -

- i. The Institute of History of Medicine and Medical Research Society (Regn. No. S-2115 of 1962);
- ii. Indian Institute of Islamic Studies (Regn. No. 2200 of 1963);
- iii. Hamdard College of Pharmacy (Regn.No. 5641 of 1973); and
- iv. Hamdard Tibbi College (Regn. No. Regn.No.2286 of 1963)

4. On 10.05.1989, the Government of India, Ministry of Education (erstwhile MHRD) declared 'Jamia Hamdard' as deemed to be University under Section 3 of the University Grants Commission Act, 1956 after settling and approving the first Memorandum of Association and Rules of the Jamia Hamdard.

5. The term of 'sponsoring body' was brought in by the UGC through its Regulations governing the deemed to be Universities. In the above content, a clarification was sought by the Jamia Hamdard from the Ministry of Education to the effect who will act as sponsoring body either 'Hamdard National Foundation' or Jamia Hamdard Society vide letter dated 24.5.2024. In response to the said query, the Ministry of Education vide letter dated 15.1.2025 categorically stated that the 'sponsoring body' of the Jamia Hamdard will

be the Jamia Hamdard Society. The contents of the said letter from the Under Secretary, ICR Division, Ministry of Education, Department of Higher Education Ministry of Education letter F. No. 12-15 /2024-U3(A) dated 15.01.2025 (addressed to the Vice-Chancellor, JH) are reproduced below:

"The matter has been examined considering the report of UGC Expert Committee, Letter of Intent dated 20.03.1989 of this Ministry and DDA's letter dated 16.06.1993 for transferring of plot of land to the Institution.


After examining these documents, it is evident that Jamia Hamdard Society was the exclusive Society for created the Institution deemed to be University, after amalgamation of six Institutions namely (i) The Institute of History of Medicine and Medical Research; (ii) Indian Institute of Islamic Studies; (iii) Hamdard Tibbi College; (iv) Hamdard College of Pharmacy; (v) Majeedia Hospital; and (vi) The School of Nursing in the name of Jamia Hamdard, New Delhi. It is further clarified that, as per the records available with the Ministry, no change in respect of Jamia Hamdard Society has been done by the Ministry".

6. The said letter F. No. 12-15 /2024-U3(A) dated 15.01.2025 was placed before the Executive Council in its 70th Meeting held on 27.02.2025 for its consideration.

"The EC after due deliberations resolved to adopt the Department of Higher Education Ministry of Education letter F. No. 12-15 /2024-U3(A) dated 15.01.2025 for incorporation in the new MOA to be framed as per UGC Regulations, 2023".

7. Subsequently, the resolution of the Executive Council was ratified by the Jamia Hamdard Society in its 7th Meeting held on 18.03.2025. Consequently, it is notified to all concerned that the 'Jamia Hamdard Society' is the 'sponsoring body' of Jamia Hamdard (Deemed to be University) for all purposes in the light of the Govt. of India letter dated 15.01.2025.
